Request for Quotation (RFQ) for Listing of Suppliers and their Products Related to Tented, Prefabricated Structures and Similar Products for State of Meghalaya

Proposals are hereby invited from the intending Agencies/Suppliers for supply of their Products related to Tented Structures, Prefabricated Structures and other similar products for State of Meghalaya as per Indian Standards:

A. Background

In the light of the impact that the COVID-19 pandemic has had on the normal functioning of our daily lives, there was a genuine felt need for housing structures that could be set up in a very short time frame, be it in the health sector or the tourism sector or sports infrastructure etc., or any other field and this is the very reason for this RFQ. The Government of Meghalaya(GoM) and its respective departments were hamstrung in the procurement aspect of these new age structures (even though a majority of them were readily available as finished products in the open market along with a Marked Retail Price) whereas the pressure to obtain them at the earliest was acutely felt. Thus the only way that would resolve these difficulties was to issue an open invite through a very general RFQ for obtaining detailed designs, specifications etc., and their respective price quotes for wide ranging innovative Pre-Fabricated Housing products (from high-end luxury to basic products) that are currently available in the market. The scope of such products is not limited to any specific field or genre but the only necessity is that these products should be currently available in the open market at the time of inviting this RFQ.

B. Scope of work:

- i. Supply, Installation, Testing Commissioning of Tented/Prefabricated Modular Construction Technology/ Similar Products on Turnkey Basis in state of Meghalaya as per Indian Standards:
- ii. Project site shall be across Meghalaya.

C. Duration for listing of Suppliers and their products:

I. **Time duration for listing of suppliers and their product**: This listing shall be valid for 2 Years from the date of issuance of final list of Suppliers.

D. Eligibility Criteria:

- i. The Agency shall be a company/Partnership/Proprietorship or any other legal establishments. Proof of establishment needs to be submitted along with proposal.
- ii. The Agency must have valid PAN and GST Numbers. Copy of PAN and GST number shall be provided along with proposal.
- iii. The Agency must not have been debarred / blacklisted by any government entity in India as on the last date of Proposal submission.
- iv. Consortium or JV is allowed. In case of consortium association letter as per 'Form C' shall be submitted along with technical proposal.
- v. Dealer or Distributor of the products shall submit the proof of association with the original manufactures of the products.
- vi. The Agency must have prior experience in supply of facilities as per scope. using the prefabricated construction technology or Tented structures as per 'Form D'

- i. Technical Proposal: Agency shall submit 'Form A' and 'Form B' 'Form C' 'Form D' along with self-attested documentary evidence to prove eligibility under Section B, Clauses i, ii, iv& v of this document.
- ii. Presentation: Agency shall submit a presentation detailing the technology, solution, envisaged layout, dimensions, specifications, etc. The Agency shall make a presentation via video conference. Date shall be communicated to the eligible agencies through email.
- iii. Financial Quotation: Agency shall submit the financial quotes of their products along with specifications as per their internal formats. Quoted rate of individual products shall be excluding GST.
- iv. Mode of submission: Technical Proposal, Presentation & Financial Quotation shall be submitted in the PDF files, separately.
