#### Scope of Work:

#### I. Deepening Program Design:

- Network with various national agencies, development agencies, multi-lateral and bi-lateral agencies; Foundations and CSR funds for mobilizing fund support for promotion of goods and services in the catchment areas of MBDA/MBMA.
- Develop promotional material and knowledge modules for information and reference of the various stake holders
- Disseminate information and generate knowledge for application of the MBDA/MBMA work.
- Facilitate linkage of private sector companies and bodies who will help in growth and development of the MBDA/MBMA ethos of 4Ps.
- Program design be such to deepen engagement of community in developing private sector delivery of goods and services with a view to instil more sustainability

## IV. Individuals meeting the following eligibility criteria are invited to apply:
