1. Ka sorkar Meghalaya ka don ha ka bynta ban wanrah ia ki kyndon treikam kiba janai na ka bynta ban kyntiew ia ki kam ki jingtrei bad ki jingseng kam seng jam kiba rit ha kylleng ki block jong ka jylla. Ka jingthmu jong kane ka kyndon treikam ka long ban wanrah ia ka jingioh nong bad ka kamai ka kajih kaba iaineh kaban wan lyngba ki kam kiba iadei bad ka rep ka riang kumjuh ruh bad kiwei kiwei ki jait kam. Ia kine ki kam yn pyniasoh sha ki iew ki hat ha ka jylla bad shabar jylla ruh kumjuh, da kaba pyniaid ia ki kam kiba iadei bad kumno ban sañ pynbha ia ki mar ki mata bad pyniaid ia ki na kawei ka bynta sha kawei pat. Ka jingthmu jong kane ka liang ka long ban wanrah ia ki kam ki jingtrei kiba iai neh bad kiban ai jingmyntoi ha kaba yn lah ban rat ia ka jingduk jingkyrduh.
2. Ka sorkar jylla Meghalaya lyngba ka shnat treikamm jong ka Meghalaya Basin Management Agency (MBMA), ka kwah ban don ka jingiatreilang bad ki kynhun ne riew shimet kiba lah ban trei ia kine ki jait kam khnang ba kin iasam lem ia ki jingtip bad jingshemphang jong kine ki kynhun ha kaban kyntiew ia ki kam kiba iadei bad kine ki Growth Hubs (GHs). Kino kino ki kynhun ne shnat treikam kiban shah jied yn sa thung bad pynlong ia ki kum ki Community Anchors (CAs) ne ka kynhun ban iarap btin lynti ia ki shnong ki thaw ha ki block/district.
3. **Jingthmu: Ka jingthmu jong kane ka kam kan long:**
 - a. Ka kynhun kaba trei ia ka kam kum ka Community Anchor's kadei ban ai jingkyrshan ia bun tylli ki jait kam ha ri lum Garo.
 - b. Ban ai jingkyrshan ia ki kam ki jam bapher bapher na ka bynta ki nongseng kam lajong kiba la pynrung kyrteng ia lade ha ki EFC bad ban thaw ia ki jaka ban saindur, ai jinghikai bad pynbha ia ki kam ki jam na ka bynta ki nongseng kam lajong ha baroh ki "Growth Hubs" jong ka jylla.
 - c. Kine ki kynhun treikam ki don ka kamram ban peit ia ka jingtreikam jong ki bynta treikam bapher bapher jong kine ki Growth Hubs kata EFCs, Rural Technology Parks, Incubators.
 - d. Dei ban pyntikna ba ia ki jingshakri ne ki jinghikai kiba la ai na ka bynta ki briew jong ka thain ri lum Garo kidei ban long kiba lah ban ai jingmyntoi ia kiba bun ki longiing ha ka thain hi baroh kawei.
 - e. Ban iarap bad btin lynti ha kaban iasam ia ki jingtip bad hapdeng ki briew shimet bad ki tnad treikam jong ka sorkar.

f. Ban pyniasoh sha ki “Growth Hubs” ryngkat ka jingkyrshan bad jingshakri jong ki tnad sorkar ha ki block.

4. **Ka jingjlan jong ka por ban trei:** Ka por ne ka samoi ban trei ia kane ka kam kan long 12 bnai naduh ka sngi ba la ai ia ka contract sha ki. Lada donkam lah ban bteng shuh shuh ia ka samoi treikam bad kane yn leh lyngba ka jing ia sngewthuh hapdeng ki kynhun. Lah ban bteng ia ka la ka draft jong ki kyndon treikam lah ban ioh lyngka website www.mbda.gov.in. **Kino kino ki kynhun kiba sngew kwah ban trei ne Terms of Reference (TOR) ia kane ka kam ki lah ban pule ia ka ToR ia kaba yn sa pynbit pynbiang nadong shadong ha ka taiew ban wan khnang ban sngewthuh shai shaphang ki kyndon.**
5. Ka Meghalaya Basin Management Agency ka khot ka wer ia ki kynhun treikam bapher bapher ba kynthup ia ki firms/NGOs/Trusts/ Societies/ Cooperatives ba kin pynpaw iak a jingsngew kwah jong ki ban ai ia kine ki jingshakri. Lada lai tylli ki kynhun ki kwah ban iasoh lang ki lah ban phah ia kajuha ka EOI.
Ki kynhun kiba kwah ban trei ne ai ia ki jingshakri kidei ban phah ia ki jingtip ba bniah da kaba pynpaw ia ka jinglah jong ki bad ka jingiahap katkum ka jingdonkam jong ka kam. Ia ki kyndon ban kdew kumno yn jied ia ki kynhun yn sa thoh ha ka Annexure – A. **Ki kynhun ki hap ban pyniaid ia ka kam ha ki 29 tylli ki block jong ki 11 tylli ki Distrik jong ka jylla, kumta ki kynhun ki hap ban da pynpaw hangno ki kwah ban pyntrei ia ka kam jong ki katkum ka Annexure - B. Hynrei, wat la katta ruh, ka MBMA ka don ia ka hok ban bhah ia ki kynhun ban trei ia ka kam jong ki ha kino kino ki block katkum ka jingbit jong ka kynhun hadien ba la bishar ia ki jinglah jong ki.**
6. Lyngba kane ka Expression of Interest, ka MBMA kan pynlong ia ka jingjied ia ki kynhun kiban ai jingshakri. Ka jinglut jingsep bad ki jingdonkam ia ka pisa pilaiñ na ka bynta ban pyniaid ia ka kam jong ka Growth Hubs yn leh katkum ka PPP mode bad ia kane yn sa leh hadien ba la dep ban jied ia ki.
