 - 3 (b) Accommodation: Rates of rooms per/head and sharing (i) Single (ii) Double (iii) Triple with types of bed (Twin/Queen/Kingsize Bed), etc. rates are to be clearly mentioned.
 - 3 (c) Rooms/Food Service: Rates of foods per/head (i) Lunch (ii) Dinner (iii) Breakfast in which food items like Indian Dish/ Local/Chinese, etc. rates are to be clearly mentioned.
 - 3 (d) **Rental of hall/conference hall:** Rental rates of Conference Hall as per size/ area of the hall may clearly mentioned.
 - 3 (e) **Rental of Training Hall**: Rental Rates of the Training Hall as per the size / area including tools set up of the training may clearly mentioned.
 - 3 (f) **Food Catering:** Rates for food catering per/head (i) Lunch (ii) Dinner (ii) Breakfast in which Menu in Indian Dishes/Chinese/Local and others which includes Thali/general Thali, etc.

4. Terms and Conditions

- The Authority of PRIME HUB reserves the right to withdraw the agreement at any stage if such action is in the best interest of the management.
- Opening of Sealed envelope shall be on the same day of the last date of submission of (EOI) in which it will be opened by the members of the Technical and Financial Evaluation Committee in the presence of participated firms.
- The period of contract will be on continuous agreement of which if so required for changes of the terms and conditions, the consensus rates/tariff shall be informed officially by writing or email to prime.urbanshillong.mbma@gmail.com. If provision for validity after review of the price escalation shall be considered upto a maximum limit of 5% per annum to absorb the increase in the input costs. The increase in Rates/ Tariff will be decided mutually. The activation of escalation clause must be requested by the hotel/guest house/resort, etc. However, the rates if approved shall remain fixed for at least three years of contract.
- The office Of PRIME HUB reserves the right to accept/reject any offer of (EOI) in part or full, without assigning any reason whatsoever.
- An inspection of Rooms/Hall and Facilities, etc. shall be conducted by the Committee after the
 evaluation of financial offers which shall be finalised from the Financial comparative statement
 on Cost Standard and quality based, thereafter the committee will recommend the names of
 Hotels/Guest House/ Resort, Firms suitable for empanelment and awarding of contract.
- The Contract for empanelment with the Office of PRIME Hub, J.N. Sports Complex Polo, Shillong for providing Accommodation and food shall be selected for more than 10 firms located in Shillong in an area within 10 Kilometer from the office.
- If any amendment of the terms and conditions it will upload its response together with any amendment to this document, on www.mbda.gov.in for information of all Firms should check on the website, for any amendments to the terms and conditions and for Award of Contract.
- Physical visit of hotel premises (if required) to check the services, amenities and credentials of the hotel by the Committee constituted for this purpose for recommending the names of suitable hotels.

5. Qualification:

Eligibility: A Firm (a) shall not participate in more than one Proposal; (b) shall not have conflict of interest (c) shall not have been blacklisted or suspended by State Government.

- (i) Firms shall be able to give valid certificate of GST Registration Number and PAN Card, other documents like address proof or contact details for future reference.
- (ii) Self- declaration to the effect the Firm is not insolvent, in receivership, bankrupt or being wound up or subject to legal proceedings for any of these circumstances.

- (iii) Business activities are not suspended or debarred from any reason by the declaration to the effect the Firm is not insolvent, in receivership, bankrupt or being wound up or subject to legal proceedings for any of these circumstances.
- **6. Evaluation Criteria and Method of Evaluation:** A firm will be selected under Quality and Cost Based Selection (QCBS) procedures. Financial and Technical aspects shall be evaluated and grants the recommendation for selection of Firms as described at 3. Above.
- **7. Response** Bidders must ensure that their Bid response is submitted as per the formats attached with this document.

8. Conflict of Interest:

- i) Where there is any indication that a conflict of interest exists or may arise, it shall be the responsibility of the Bidder to inform PRIME HUB, Shillong, detailing the conflict in writing as an attachment to this Bid.
- ii) PRIME HUB, Shillong will be the final arbiter in cases of potential conflicts of interest. Failure to notify PRIME Hub, Shillong of any potential conflict of interest will invalidate any verbal or written agreement.
- iii) A Conflict of Interest is where a person who is involved in the procurement has or may be perceived to have a personal interest in ensuring that a particular Bidder is successful. Actual and potential conflicts of interest must be declared by a person involved in a Bid process.
- **9. Conditions under which EOI Issued**: The EOI is not an offer and is issued with no commitment. PRIME HUB reserves the right to withdraw EOI and or vary any part thereof at any stage. It further reserves the right to disqualify any bidder, should it be so necessary at any stage.
