## Section I - Instructions to Bidders

### A. General

1. <b>Scope of Bid</b>	<p>1.1 In connection with the Specific Procurement Notice, Request for Bids (RFB), specified <b>in the Bid Data Sheet (BDS)</b>, the Purchaser, as specified <b>in the BDS</b>, issues this bidding document for the supply of Goods and, if applicable, any Related Services incidental thereto, as specified in Section VII, Schedule of Requirements. The name, identification and number of lots (contracts) of this RFB are specified <b>in the BDS</b>.</p> <p>1.2 Throughout this bidding document:</p> <ul style="list-style-type: none"> <li>(a) the term “in writing” means communicated in written form (e.g. by mail, e-mail, including, if <b>specified in the BDS</b>, distributed or received through the electronic-procurement system used by the Purchaser), with proof of receipt;</li> <li>(b) if the context so requires, “singular” means “plural” and vice versa; and</li> <li>(c) “Day” means calendar day, unless otherwise specified as “Business Day”. A Business Day is any day that is an official working day of the Purchaser. It excludes the Purchaser’s official public holidays.</li> </ul>
2. <b>Source of Funds</b>	<p>2.1 M-LEADS</p> <p>2.2 NA</p>
3. <b>Not Used</b>	3.1 NA
4. <b>Eligible Bidders</b>	4.1 A Bidder may be a firm that is a sole proprietorship, (ITB 4.6), or any combination of such entities in the form of a joint venture (JV) under an existing agreement or with the intent to enter into such an agreement supported by a letter of intent. In the case of a joint venture, all members shall be jointly and severally liable for the execution of the entire Contract in accordance with the Contract terms. The JV shall nominate a Representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the Bidding process and, in the event the JV is awarded the Contract, during contract execution. Unless specified <b>in the BDS</b> , there is no limit on the number of members in a JV.



	<p>4.2 A Bidder shall not have a conflict of interest. Any Bidder found to have a conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest for the purpose of this Bidding process, if the Bidder:</p> <ul style="list-style-type: none"><li>(a) directly or indirectly controls, is controlled by or is under common control with another Bidder; or</li><li>(b) receives or has received any direct or indirect subsidy from another Bidder; or</li><li>(c) has the same legal representative as another Bidder; or</li><li>(d) has a relationship with another Bidder, directly or through common third parties, that puts it in a position to influence the Bid of another Bidder, or influence the decisions of the Purchaser regarding this Bidding process; or</li><li>(e) or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the works that are the subject of the Bid; or</li><li>(f) or any of its affiliates has been hired (or is proposed to be hired) by the Purchaser or Borrower for the Contract implementation; or</li><li>(g) would be providing goods, works, or non-consulting services resulting from or directly related to consulting services for the preparation or implementation of the project specified in the BDS reference ITB 2.1 (MLEADS), that it provided or were provided by any affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm; or</li><li>(h) has a close business or family relationship with a professional staff of the Borrower (or of the project implementing agency, or of a recipient of a part of the loan) who: (i) are directly or indirectly involved in the preparation of the bidding document or specifications of the Contract, and/or the Bid evaluation process of such Contract; or (ii) would be involved in the implementation or supervision of such Contract.</li></ul> <p>4.3 A firm that is a Bidder (either individually or as a JV member) shall not participate in more than one Bid, except for permitted alternative Bids. 	<p>4.4 A Bidder may have the nationality of any country, subject to the restrictions pursuant to ITB 4.8. A Bidder shall be deemed to have the nationality of a country if the Bidder is constituted, incorporated or registered in and operates in conformity with the provisions of the laws of that country, as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be. This criterion also shall apply to the determination of the nationality of proposed subcontractors or subconsultants for any part of the Contract including related Services.</p> <p>4.5 NA.</p> <p>4.6 Bidders that are state-owned enterprises or institutions in the Purchaser’s Country may be eligible to compete and be awarded a Contract(s) only if they can establish, that they (i) are legally and financially autonomous (ii) operate under commercial law, and (iii) are not under supervision of the Purchaser.</p> <p>4.7 A Bidder shall not be under suspension from Bidding by the Purchaser as the result of the operation of a Bid/Proposal–Securing Declaration.</p> <p>(a) NA.</p> <p>4.8 A Bidder shall provide such documentary evidence of eligibility satisfactory to the Purchaser, as the Purchaser shall reasonably request.</p> <p>(a) NA.</p>
<p><b>5. Eligible Goods and Related Services</b></p>	<p>5.1 NA</p> <p>5.2 For purposes of this ITB, the term “goods” includes commodities, raw material, machinery, equipment, and industrial plants; and “related services” includes services such as insurance, installation, training, and initial maintenance.</p> <p>5.3 The term “origin” means the country where the goods have been mined, grown, cultivated, produced, manufactured or processed; or, through manufacture, processing, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its components.</p>

	<p>6.2 The Specific Procurement Notice - Request for Bids (RFB) issued by the Purchaser is not part of this bidding document.</p> <p>6.3 Unless obtained directly from the Purchaser, the Purchaser is not responsible for the completeness of the document, responses to requests for clarification, the Minutes of the pre-Bid meeting (if any), or addenda to the bidding document in accordance with ITB 8. In case of any contradiction, documents obtained directly from the Purchaser shall prevail.</p> <p>6.4 The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding document and to furnish with its Bid all information or documentation as is required by the bidding document.</p>
<b>7. Clarification of the Bidding Document</b>	<p>7.1 A Bidder requiring any clarification of the bidding document shall contact the Purchaser in writing at the Purchaser’s address specified <b>in the BDS</b>. The Purchaser will responder in writing to any request for clarification, provided that such request is received prior to the deadline for submission of Bids within a period specified <b>in the</b></p>

	<p><b>BDS.</b> The Purchaser shall forward copies of its response to all Bidders who have acquired the bidding document in accordance with ITB 6.3, including a description of the inquiry but without identifying its source. Language of Bid</b></p>	<p>10.1 The Bid, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Purchaser, shall be written in the language specified <b>in the BDS</b>. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages into the language specified <b>in the BDS</b>, in which case, for purposes of interpretation of the Bid, such translation shall govern.</p>
<p><b>11. Documents comprising Bid</b></p>	<p>11.1 The Bid shall comprise two Parts, namely the Technical Part and the Financial Part. Where material financial information related to the Bid price is contained in the Technical Part the Bid shall be declared non-responsive.</p>

	<p>11.5 In addition to the requirements under ITB 11.1, Bids submitted by a JV shall include a copy of the Joint Venture Agreement entered into by all members. Alternatively, a letter of intent to execute a Joint Venture Agreement in the event of a successful Bid shall be signed by all members and submitted with the Bid, together with a copy of the proposed Agreement.</p> <p>11.6 The Bidder shall furnish in the Letter of Bid information on commissions and gratuities, if any, paid or to be paid to agents or any other party relating to this Bid.</p>
<p><b>12. Letters of Bid</b></p>	<p>12.1. The Bidder shall prepare the Letter of Bid – Technical Part, and Letter of Bid – Financial Part using the relevant forms furnished in Section IV, Bidding Forms. The forms must be completed without any alterations to the text, and no substitutes shall be accepted except as provided under ITB 20.3. All blank spaces shall be filled in with the information requested.</p>
<p><b>13. Alternative Bids</b></p>	<p>13.1. Unless otherwise <b>specified in the BDS</b>, Alternative Bids shall not be considered.</p>
<p><b>14. Bid prices and Discounts</b></p>	<p>14.1 The prices and discounts quoted by the Bidder in the Letter of Bid - Financial Part and in the Price Schedules shall conform to the requirements specified below.</p> <p>14.2 All lots (contracts) and items must be listed and priced separately in the Price Schedules.</p> <p>14.3 The price to be quoted in the Letter of Bid - Financial Part, in accordance with ITB 12.1 shall be the total price of the Bid, excluding any discounts offered.</p> <p>14.4 The Bidder shall quote any discounts and indicate the methodology for their application in the Letter of Bid - Financial Part, in accordance with ITB 12.1.</p> <p>14.5 Prices quoted by the Bidder shall be fixed during the Bidder's performance of the Contract and not subject to variation on any account, unless otherwise specified <b>in the BDS</b>. Evaluation of Technical Parts</b></p>	<p>30.1 In evaluating the Technical Parts of each Bid, the Purchaser shall use the criteria and methodologies listed in ITB 31, ITB 32, the BDS, if applicable, and Section III, Evaluation and Qualification Criteria. No other evaluation criteria or methodologies shall be permitted.</p>

<p><b>32. Qualification of the Bidders</b></p>	<p>32.1 The Purchaser shall determine, to its satisfaction, whether all eligible Bidders, whose Bids have been determined to be substantially responsive to the bidding document, meet the Qualification Criteria specified in Section III, Evaluation and Qualification Criteria.</p> <p>32.2 The determination shall be based upon an examination of the documentary evidence of the Bidder’s qualifications submitted by the Bidder, pursuant to ITB 17. The Letter of Bid - Financial Part and the Price Schedules are to be initialed by a representative of the Purchaser attending the Bid opening in the manner specified <b>in the BDS</b>.</p> <p>33.6 The Purchaser shall neither discuss the merits of any Bid nor reject any envelopes marked “FINANCIAL PART”.</p> <p>33.7 The Purchaser shall prepare a record of the Financial Part of the Bid opening that shall include, as a minimum:</p> <ul style="list-style-type: none"> <li>(a) the name of the Bidder whose Financial Part was opened;</li> <li>(b) the Bid price, per lot (contract) if applicable, including any discounts,</li> <li>(c) if applicable, any Alternative Bid - Financial Part.</li> </ul> <p>33.8 The Bidders whose envelopes marked ‘FINANCIAL PART’ have been opened or their representatives who are present shall be requested to sign the record. ### **3.2 Technical specification for TAG APPLICATOR/CLIPPER**

The applicator and its pin should be reliable for mass Tagging and should be supplied by ear tags suppliers for ear Tag. The pin should be reliable for a minimum of 2,000 ear Tag applications. Undertaking for the same shall be given by the bidder/supplier.

1. The applicator should be branded with the manufacturer's name /logo engraved on the metal portion on the upper applicator's jaw.
2. Two extra/spare pins should be supplied along with each applicator and located in the applicator's handle.
3. The applicator' weight should not exceed 300 gms +-10%.

### **3.4 Physical Characteristics:**

1. The inner and outer surface of the Tag should be smooth.
2. The borders of the Tag should be smooth without any roughness and ridges. The edges of the Tag shall be free from visible nicks and cuts.
3. The Tag shall be free from un-dispersed raw material, streak and particles of foreign matter, tears and blisters.
4. The Tag shall be uniformly smooth, straight and of uniform color throughout the length.
5. The outer surface of Tag should be suitable to ensure easy clear and permanent laser printing as per numbering pattern.
6. The Tag shall not develop any crack, bulging and deformity and shall hold the laser printing.
