

The Expression of Interest for hiring of Project Management Consultants for Community-Based Forest Management and Livelihood Improvement in Meghalaya was floated on 19th January 2021 at <https://mbda.gov.in> and the same was also advertised on 19th January 2021 in three National Newspapers viz; The Hindu, The Telegraph and The New Indian Express. The last date for submission of the Eols were extended twice viz; (i) Corrigendum 3 vide No. MBDA/JICA/22/2020/236 dated Shillong the 16th February 2021 whereby the last date for submission was extended from 19th February 2021 to 08th March 2021 (ii) Corrigendum 4 vide No. MBDA/JICA/22/2020/259 dated Shillong the 05th March 2021 whereby the last date for submission was further extended from 08th March 2021 to 11th March 2021. 


1. The Chairman welcomed all the members and the bidders present (Attendance Sheet enclosed). Only one representative from KPMG was present during the opening.
