Terms of Reference for Operation and Management of Growth Hubs

1. Background and Context

- a. The Government of Meghalaya (GoM) is in the process of implementing a comprehensive strategy for building livelihoods and nano enterprises across all blocks of the state. The underlying principle of this strategy will be to provide continuous assured income through various farm and off farm enterprises. These enterprises will be linked to markets, local and national, with a focus on developing the entire value chain of these activities. The overarching objective will be to have sustainable livelihoods as pathways out of poverty.
- b. "Growth Hubs" (GH) across all blocks will form the epicentre of this strategy which will provide the necessary support for these farm and off farm enterprises. These GHs will comprise of Enterprise Facilitation Centres (EFCs), Rural Technology Park /Mini Industrial Estate and Incubators for enterprises. GHs will provide services ranging from training and capacity building, knowledge services, facilitating credit linkages, market linkages, business infrastructure etc to interested citizens.
- c. Community Anchors (CAs) are a key player in these GHs. They will primarily be local Non Government/ Not for Profit Organizations/ Cooperatives/Societies/Charitable Trusts/ Village Organisations active in the block/ district with grass root level presence and good rapport with the community. CAs will act as a catalyst in the effective implementation and delivery of services in the GHs by acting as a bridge between the community and the GHs.
- d. The GOM recognizes that there are several grassroot level organizations in the state that have been working with the community in the area of livelihoods and enterprise promotion.
- e. The GOM through its not-for-profit company, Meghalaya Basin Management Agency (MBMA), proposes to enter into a public private partnership with such eligible organizations to leverage the knowledge and expertise of these

organizations in managing these GHs. Such eligible organizations will be designated as Community Anchors (CAs) in the specified blocks/districts

2. Objectives of the assignment

- a. The organization will provide comprehensive range of services in the GHs as Community Anchors.
- b. Facilitate enterprise incubation programme to support the entrepreneurs registered with the EFCs and creating/upgrading and incubating enterprises across all "Growth Hubs" of the state.
- c. The organization will be responsible for the functioning of all components of the Growth Hubs i.e. EFCs, Rural Technology Parks, Incubators.
- d. Ensuring that the services offered by the GHs are accessed by large number of rural households/
- e. Facilitating the exchange of skills between the public and private sector.
- f. Providing linkages to the "Growth Hubs" with the extension services of departments at the block level.

3. Scope of work / Service Description

The selected organization will be responsible for operating all of the following components of the GH in the allocated block/district.

- a. Enterprise Facilitation Centres
 - ✓ Registration of citizens willing to avail of services
 - ✓ General Services- Awareness Building, Capacity Building programs,

 Business Skills and Soft Skills trainings
 - ✓ Monitoring and follow up

b. Incubators

- ✓ Sector specific based on major product of the block
- ✓ Provide common business infrastructure Storage, Input supplies etc

✓ Facilitate credit linkages from banks and eligible government schemes

c. Rural Technology Park

- ✓ Assist in up scaling with collaboration Knowledge partners with market orientation
- ✓ Identify critical gaps and address them by enhancing the quality and marketability of the products having an eye on market demand.
- ✓ Training to entrepreneurs for skill upgradation .
- d. Recruitment, Selection, Capacity Building and deployment of relevant manpower to manage these institutions.

4. Geographical coverage

This assignment will cover the 29 blocks located across 11 districts of Meghalaya as below. Eligibile organisations have to indicate the blocks they intend to work in response to this advertisement.

5. Responsibilities

- a. MBMA provide access to infrastructure in the blocks where selected organizations will run/ operate the GHs.
- b. MBMA will set up necessary infrastructure such as Rural Technology Parks, Incubators etc in the blocks.
- c. MBMA will independently evaluate the effectiveness of the assignment at various intervals during the tenure of the assignment.
- d. MBMA will provide operating funds to the selected organisations for a defined period to be mutually agreed by the two parties.
- e. At the end of the defined period, the selected organisations, should have developed a viable business model to run the GHs on their own.
- f. The selected organisations will recruit relevant manpower to be posted in the GHs and MBMA will provide necessary training and capacity building support to the manpower.
- g. The selected organisations will run the GHs in a professional manner and ensure that the targets for the GHs are achieved.

- b. External Monitoring: Independent evaluating Agencies will conduct Annual Evaluation of the progress.

8. Eligibility Criteria

- a. Any institution(s) registered as a trust, society, and cooperative that has demonstrated experience of working with grass root level institutions across North East India. Experience of working indifferent blocks and districts in Meghalaya would be preferable. Consortium upto a maximum of three eligible agencies is allowed to participate in the EOI.
- b. The institution(s) should have knowledge and experience of agriculture related livelihood issues, including technology, marketing, training etc. and has the necessary human resources to support these activities.
